## **AGM 2020 UPDATE**

Due to the Covid 19 pandemic, the AGM was held in an unusual format this year. All members were sent an individual copy of the Annual Report for 2019-2020 and Guilds were asked to discuss, complete and return the Postal Vote Adoption form. On 11th September the votes were counted by June Lawless of the Procedures Committee. There was an impressive return of this form with the following results.

240 Yes 2 No 4 undecided








#### THE HISTORY OF THE GUIDLS IN MAYO FEDEDRATION
