2. Competitors must be over the age of 18 years on 1st January 2021.

3. Professional chefs are excluded from competing.

4. Competitors please note that at the National Finals, competitors will be obliged to use the ingredients supplied by Aldi on the day. Any ingredients not available in Aldi must be listed and presented in non- branded containers

One Million Stars Ireland is a community arts project that connects members of the community through the art of weaving stars and holding public star installations. The stars resent love, light and solidarity against violence and the exhibitions raise funds for local women's refuges while raising domestic violence awareness and a call to action to create social change. Women's Aid figures for the second half of last year saw a 40 % increase in calls to Women's Aid. These are stark figures in a what has been a very difficult year for many. Our stars represent hope for a safer future for all and an end to all violence.

ICA members in Kilkenny, Tipperary and Mayo wove stars for the ten thousand Stars exhibition in Kilkenny and the exhibition at The Medieval Mile Museum with The Irish Craft Council of Ireland. They have exhibited in Kilkenny Castle and the City Hall. The project is growing each week and there are now plans to have ten thousand star exhibitions in Counties Limerick, Monaghan and Cavan. The project always welcoming new weavers to our community and they invite ICA members across the country could join and help achieve their mission if reaching one million stars to end violence for Ireland.
